York County SPCA Purpose:	

The York County Society for the Prevention of Cruelty to Animals (YCSPCA) is a charitable organization dedicated to providing long-term human and animal services to residents of York County through programs that find permanent, loving homes for displaced and stray animals, help control animal population growth, investigate, and prosecute cruelty offenders and educate the general public about animal wellness and safety.

Position Overview:

The clinic attendant is vital in supporting our high-volume, low-cost spay/ neuter clinic in providing spay/neuter services for dogs and cats in the community. Clinic volunteers are crucial to helping the veterinary staff team manage the number of clients utilizing their services by accomplishing key daily tasks.

In 2023, the spay/neuter clinic completed more than 11,000 surgeries. On its busiest days, the team can perform upwards of 65 surgeries. This work would not be possible without the support of volunteers.

The spay/ neuter clinic is open Mondays through Friday (no weekend opportunities available).

- There are two shifts available:
 - Mid-day shift: 10:00 a.m. 2:00 p.m.
 - PM shift: 2:00 p.m. 4:00 p.m.

Essential Functions:

- Assist the surgical staff to maintain their productivity by performing crucial clinic tasks including, but not limited to:
 - Scrubbing, sanitizing, and sorting surgical instruments.
 - Washing, folding, and putting away laundry.
 - o Cleaning the general area, making sure it is free of obstructions and obstacles.
 - Assisting with the animal checkout process.

Education and Experience:

Required:

- Must be 18 years of age or older.
- Must have reliable transportation to and from the spay/ neuter clinic.
- Must attend YCSPCA New Volunteer Open House, Orientation, initial training, and any future training required by the volunteer coordinator.
- Volunteers are required to carefully review and consent to the guidelines outlined in the volunteer handbook, including, but not limited to, social media communication and interaction guidelines.

Skills and Abilities:

- Possesses a strong passion for the York County SPCA's mission.
- Must be able to responsibly volunteer alone, or with the support of another adult who has also undergone volunteer training.

- Effective verbal communication with other volunteers and staff.
- Works efficiently without shelter staff supervision.
- Comfortable in a surgical environment and around live animals under anesthesia if working inside the clinic.

Working Conditions and Expectations:

- Shifts are available on a first-come, first-serve basis. We prefer volunteers in this role commit to at least a weekly shift, if possible.
- Morning shift: Comfortable working in all weather conditions (rain, snow, heat, cold), as well as interacting with the public to identify their needs.
- Afternoon shift: Comfortable taking initiative to complete tasks while clinic staff are prepping and operating.
- Comfortable standing for the majority of shifts.
- Comfortable with the unique aspects of working with animals, including their natural odors and excrements, the possibility of animals experiencing medical conditions, the chance of minor bites and scratches, and exposure to moderate noise levels.
- Volunteers will be expected to sign up for shifts, log their hours, complete training, communicate with other volunteers and staff, etc., using a digital database that is accessible via computer and/or cellular application, which they will receive training for.
